Counsel Report

Forward Pinellas Interlocal-Planning and Mapping

It was noted that by Counsel that this is a standing interlocal that expires September 30, 2022. This will extend our planning and mapping services through Forward Pinellas through September 30, 2026. It was moved by Commissioner Tolbert and seconded by Commissioner Niewiarowski to continue with this interlocal. The voice vote was unanimous.

Building Permit update

Mayor Schmidt updated the Commission that moving forward, the Town is expecting a contract with Safebuilt to provide the approvals on behalf of the Town Building Code to Pinellas County at the owner or resident expense.
